Through numerous bird walks, programs and special undertakings, such as the recent completion of the Loudoun County Bird Atlas, we have provided field tools, reported sightings and worked with other bird organizations to understand the issues facing our bird populations. We hold an annual Central Loudoun Christmas Bird Count (CBC) every year in December.

Bluebird Program - We manage a Bluebird Nest Monitoring Program. Our volunteers monitor over 50 public and private trails of boxes located throughout Loudoun County. Their work is part of critical conservation efforts conducted throughout the county. Our efforts are in coordination, and shared, with the Virginia Bluebird Society.

Butterflies - Every year Loudoun Wildlife holds a butterfly count across the county during the height of summer. Our volunteers organize into teams and head out for a day of counting. These counts are tallied and compared each year to assess the health of the species see what unique butterflies may have been uncovered and what trends are occurring in our area.

Stream Monitoring - In the Spring and Fall of every year, volunteer teams monitor stream health by conducting surveys counting benthic macroinvertebrates. The health of the streams can be identified by the macroinvertebrates present. Our data is used to recommend streams for
